- 4. The programme has been granted provisional accreditation. Nitte Meenakshi Institute of Technology, Gollahalli, Govindapura, P.B.No 6429, Yelahanka, Karnataka should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above to be eligible to be considered by the concerned Committee in NBA for further processing of the accreditation status. This could entail further extension of accreditation or a revisit, as deemed appropriate by NBA Committees.
- 5. The accreditation status awarded to the programmes as indicated in the above table does not imply that the accreditation has been granted to Nitte Meenakshi Institute of Technology.
